STAFF REPORTS

Director, Public Works, joined the meeting at 9:07 a.m.

PUBLIC WORKS REPORT

Director of Public Works, Kevin Morrison, presented his report to Council.

Kevin Morrison advised council that due to issues relating to water runoff and freeze/thaw cycles, there have been numerous areas where culverts have been freezing repeatedly, requiring steaming. Further, the following areas are presently seeing increased runoff, with water flowing over roads:

- TWP 814 between RGE RD 11 and RGE RD 12, requiring a road closure (further investigation will be required in this area when the runoff has completed to determine the cause of the water flowing over the road in this area);
- Dunvegan; and,
- Fairview Ski Hill.

There will be increased departmental activity in these areas to address the runoff and mitigate any damage to municipal road infrastructure. Department employees have been working extra hours, with some employees working over the weekends.

Councillor Robertson also advised Kevin Morrison that water has been running over TWP RD 811 between RGE RD 51 and RGE RD 52 recently. Kevin Morrison confirmed that he will inspect this area.

Council requested that preparations be made for a road tour, as well as tours of the gravel pits and the water plants.

COUNCILLOR CONCERNS

Councillor Robertson and Reeve Kolodychuk are concerned that the Municipality is repairing the same flood damaged areas year after year. Each year, the Municipality is spending funds reacting to the same issues, as opposed to being proactive and acting planning to prevent the damage. Councillor Robertson suggested a structured preventative plan over a number of years, which would involve both in-house infrastructure work as well as contracting services to complement such work. From a policy and governance standpoint, council needs to be provided detailed information regarding needs and priorities to determine how to plan and fund upcoming infrastructure construction and maintenance in a streamlined and cost-effective manner.

Councillor Przybylski has been in contact with ratepayers regarding the fees associated with the Whitelaw Spring truckfill station and has advised them of the costs associated with maintaining the Whitelaw Spring infrastructure. He was also speaking with a ratepayer regarding the utility charges as outlined in policy UTI 06 relating to unoccupied buildings (as amended during the March 8, 2022 council meeting). Councillor Przybyblski has also been advised by ratepayers that there may be a leak along the line from Whitelaw Spring to Whitelaw—there is a hump in a road and there are wet spots in areas that did not previously exist. CAO Jorgensen advised that he has instructed the Public Works Department to investigate for leaks as this is an issue that the Director, Public Works, and the Public Works Foreman have brought to his attention. Further, this may be infrastructure that may need to be fully replaced, given its age.
