# **DELEGATION - FAIRVIEW & AREA SENIORS CHECK-IN LINE SOCIETY**

Kathleen and Betty gave a presentation to Council about the services the Society provides.

The Fairview & Area Seniors Check-In Line Society has seen an increase in membership and increased usage of their services since the COVID-19 pandemic started. They ran monthly Community Kitchens providing lunch to seniors until March 2020, when the pandemic caused this to be shut down. Since September they have been doing monthly Pick-Up Kitchens. They have about 40 seniors in Fairview and 15-20 in Hines Creek that utilize this service. Prior to the pandemic they held information sessions for seniors on topics such

as Houseplant Tips and Healthy Eating for Seniors.
This year the Society received two UFA Community Volunteer grants for Fairview and Hines Creek.

Their volunteer hours are down due to the pandemic, but they will continue to promote seniors living at home and support their independence with the Check-In Line and advocacy.

#### Councillor Questions:

Reeve Johnson asked if the Check-In Line was a free service. Kathleen replied that it is. Betty said that the difference this makes in seniors' lives is amazing. Their staff and volunteers also take groceries and food to seniors. These services give seniors a feeling of community and connection; a feeling that they are not alone. Fairview FCSS has already said they will support them in 2021. Betty went on to explain that the people they serve are "not iPhone people", that the value of a good old phone call is overwhelming. It lets them know that somebody cares that they are alive. It is a much-needed service and is very rewarding.

Councillor Wieben asked for details of the funding received through UFA Strong Futures for Rural Communities. Betty explained that they received two one-time-only grants of \$500.00 each, one for Fairview and one for Hines Creek.

Sandra asked if Fairview still has a Meals on Wheels program. Betty replied that they did, before the pandemic, but they used the Hospital to source food and since the pandemic started they can no longer get access. The Community Kitchen program is not a replacement for Meals on Wheels, since they only provide lunch for seniors once a month.

Reeve Johnson asked how much a membership costs. Kathleen said that membership is \$2/ year and they also get donations from seniors at the Community Kitchen.

Sandra asked if the Society holds a volunteer appreciation event. Kathleen said they can't now, but maybe next year.
