Glenda Farnden provided Council with an update on STARS.

- Dr. Greg Powell, STARS Founder.
- STARS was born out of necessity.
- > STARS 1st Mission was December 1, 1985
- 6 STARS bases (AB/SK/MB), serving 4 provinces across Western Canada (includes eastern BC)
- > 8 missions per day (averaged) / 5 missions per day in Alberta
- > 11 Helicopters in the fleet.
- > Surpass 40,000 missions flown since 1985.
- > STARS Alberta Funding (80% fundraising and 20% provincial government funded).
- Current helicopters are 35 years old and need to be replaced. They will be replacing the fleet with the Airbus H145. Approx. cost is \$13M per helicopter.
- ➤ Goal is to purchase 9 helicopters total (5)AB, 3(SK) and 1(MB).
- > They have purchased 3 Airbus H145's with cash reserves and financing.
- ➤ The 1st Airbus H145 delivery in 2019 to the Calgary base.
- Will be building the fleet one helicopter at a time.

Glenda thanked the MD of Fairview No. 136 for the continued support. The MD has committed to an annual contribution of \$20,000.00 per year for 2018, 2019, 2020 and 2021.

AG FIELDMANS REPORT FEBRUARY 6, 2019

- Hi all. I do not have much to report on since your last later Council meeting as I had taken 4 days off last week, January 29th to Feb 1st.
- My time has been spent in the office. I have updated the spread sheets for the new 2019 rates on the per diem forms for my ASB members and completed the January per diems for them since I received all the receipts from the ASB Conference.
- I have also been trying to gain more information on cropping near airports. What I have found is that no matter what website I went on to find information on that, it leads to the same thing. It is up to the municipality that owns the airport to make decisions based on experience with our wildlife/waterfowl in and around the airport to try and make food sources unavailable to them. Personally, I feel that large scale pea fields on the property we own could be a stipulation for not growing them although I believe that is in place now on the rental agreement. A point to make is that PCBFA had 32 plots of peas south of the Research Farm approximately 50 meters north of the airport fence in 2018, (there has been no stipulations on research farm plot crop types ever), and they hadn't seen any geese on them and no sign of crop damage due to wildlife/waterfowl. Another tidbit of information I read is that jet aircraft have encountered waterfowl, (geese), at a height of 2500 feet which in one case shut down one engine out of the two. Most of the pilot's concerns are encountering them and other birds during landing and take-off at lower altitudes. As one wildlife expert mentioned in one of the articles I read, quote "there is no possible way to control any wildlife/birds at or near an airport but due diligence on the airports management team can help reduce possibilities by taking control measures with-in their budget".
- Our brush burning has been put on hold since the snowfalls Jan 31st until the present due to the cold temperatures.
- Not much more to report on. I am just continuing with office duties.



- I have attended the following meetings:

- MMSA will be hosting a meeting of all municipality CAOs interested in participating in the Regional SDAB Agreement on Feb 2. I will be away so our Development Officer is attending on my behalf. The draft agreement and policies and procedures will be reviewed for any additional municipal input.
- Town of Fairview has provided the survey regarding the physiotherapist business plan consulting work. It will be available via our website, facebook and e-notification mailout.
- The Demand Work Order I was directed to issue to the land owner of the scene of the fire in Whitelaw has been mailed by registered letter. I had our legal counsel review the document which delayed the issuance. As a result, I put a compliance deadline of March 8, 2019 instead of March 4, 2019 as indicated in Motion #19-049.
- Sandra Rendle has been working on arrangements for Councillors Skrepnek and Kolodychuk to attend the FCM Convention in Quebec City. She has determined that estimated costs for registration, hotel, airfare and meals will be \$4100. and per diem and mileage an additional \$2200.00. This does not include incidentals such as taxi or spouse programs. We will have to budget for this additional 2019 expense for these 2 wards at about \$6800 to \$7000. per ward.

North Peace Housing Foundation Board Meeting Synopsis February 6, 2019

Highlights from the Executive Director's Report:

Del-Air Lodge/DSL Options Analysis

We continue to await a final investment decision from the province.

2018 Financial Audit

Myers Norris Penny attended at our office to complete the field audit work and sampling from January 28 – 30, 2019.

The audit went well. Unfortunately, MNP will not have the statements prepared and audited in time for our March 6, 2019 Meeting. The Government of Alberta is comfortable with a draft copy prior to March 31st and the final approved and signed submissions on April 4th.

Yardi 7s

In our business plan, administration identified the desire and benefits of an upgrade to our property management software to the newer version of the Yardi Voyager enterprise solutions software.

Discussion has turned to an offer from Capital Region Housing to provide the implementation of the Yardi 7S platform at Heart River Housing and potentially at North Peace Housing. The result would be HRH and NPHF receiving a tailored implementation to the Housing Management Body operation and greatly increasing our utilization of the platform.

A business case has been developed by Capital Region Housing for submission to the GOA for funding the tailored implementation at the three HMBS and from there, potentially others.

Resident/Tenant Levels

Aggregate resident levels held steady for the Month of December. We had a total of 188 Lodge residents, no change from the previous month. Occupancy is at 81.3% occupied of the 224 Lodge suites.

We increased 2 tenants, to 123 occupied seniors' apartments and up 14 tenants since July. We now stand at 94.6% occupancy.

Garden Court had 48 units occupied at the end of December 2018, no change from the previous month. 5 of 8 Cadotte Lake trailers were occupied in December, also no change from the previous month.

Regarding Family housing, it has improved slightly in that we have 81 of 123 community housing units occupied and 26 of the 40 R&N units occupied at the end of December. This is an increase of 2 tenants and occupancy overall stands at 65.6%.

Rent supplement tenancies remained the same at 42.
