# 2019 DRAFT ICSP ACTION PLANS

Council discussed the draft 2019 ICSP Action Plans.

It was determined that Policy Meetings shall be held in conjunction with the second council meeting in September, October, November and December 2019 with the exception of the Approach Policy to be discussed at the July 2019 council meeting. Administration was directed to investigate policies of neighboring municipalities regarding the widening of farmland approaches prior to bringing changes to the MD of Fairview Approach Policy to the July meeting.

Maintenance and repairs to roads that have top soil coming through when wet was also discussed. Administration was directed to have these road repairs considered as priority in Public Works summer work scheduling.

Columbarium placement at the expanded New Waterhole Cemetery was also discussed with Council directing that the cement base pad be build large enough to accommodate a total of three columbarium in the future.

Acquisition of three privately owned lots at the Dunvegan City settlement was also discussed. As no indication whether the property owner is willing to sell the lots to the municipality has been received, no plans for purchasing were included in the 2019 Action Plans or 2019 Budget.


