TAXATION NOTICES

Your property taxation notices were mailed on June 23, 2023! Notices were mailed to property owners registered at Alberta Land Titles Office as of June 15, 2023. If you became an owner after that date or have not received a notice for any reason (including due to processing delays at Alberta Land Titles Office), it is your responsibility to obtain a copy by contacting the municipal office at 780-835-4903 or by e-mail at taxes@mdfairview.ab.ca.

CHANGE OF MAILING ADDRESS

The M.D.'s source of property ownership and mailing address information is a property's Certificate of Title. It is your responsibility to ensure that a Certificate of Title is accurate! Non-receipt of a property taxation notice does not exempt you from payment deadlines or late payment penalties. Mailing address changes must be completed through Alberta Land Titles Office - such changes are then received electronically by the M.D. and processed accordingly. The M.D. will not update a mailing address unless it is received directly from Alberta Land Titles Office.
