The delegation, Ben Schneider of Waterhole Hall (Waterhole Oldtimers' Association), joined the meeting at 9:43 a.m.

The delegation provided Council an update of the work that has been completed to maintain Waterhole Hall (built in 1916), including recent flooring repairs. The delegation requested financial assistance from the Municipality for the recent flooring repairs (in no specified amount).

The delegation left the meeting at 10:02 a.m.

The delegation, Neil and Tammy McKeachnie, Jerry Jonson, Gordon Heck and Dan Wiebe (CNRL representative), joined the meeting at 10:03 a.m.

Tammy McKeachnie expressed concerns of residents in the area regarding the slumping of the slope near Range Road 33 (Walsh's Corner) and potential

of imminent failure.

In addition to residents in the area using the road, there is active farming (grain and cattle) underway and CNRL has multiple facilities (6 active wells, 3 shut-in wells, pigging facilities etc.).

The delegation is seeking clarity on the Municipality's plans regarding the repair/realignment of Range Road 33.

Lastly, there was steel that was dug up during the rock pick up in 2023 on Range Road 23 near Bluesky; there has been concerns expressed that someone may be injured by/on this steel.

Council, as a whole, expressed concern that bylaw enforcement has not been active relating to enforcement of the Community Standards Bylaw in the Hamlets.
