PUBLIC HEARING - BYLAW NO. 1008/DEV/2024

MOTION #25-006 Councillor Robertson Moved that Council open the Public Hearing for Bylaw No. 1008/DEV/2024 at 9:35 a.m.

PURPOSE OF THE HEARING

Reeve's Statement:

Section 632 of the *Municipal Government Act*, R.S.A 2000, c. M-26, requires the council of every municipality to by bylaw adopt a Municipal Development Plan.

The Council of the Municipal District of Fairview No. 136 deems it desirable to repeal and replace the current Municipal Development Plan (Bylaw No. 868) with a new a Municipal Development Plan (Bylaw No. 1008) that reflects the current conditions and aspirations of the community.

The Council of the Municipal District of Fairview No. 136 is satisfied that the relevant requirements pertaining to the preparation and adoption of the Municipal Development Plan have been complied with.

Pursuant to Sections 632, 606 and 692 of the Province of Alberta *Municipal Government Act*, the Municipal District of Fairview No. 136 Council, duly assembled, hereby enacts as follows:

A. TITLE

1. This Bylaw may be referred to as "Municipal District of Fairview No. 136 Municipal Development Plan".

B. PROVISIONS

- 2. That the document titled "Municipal District of Fairview No. 136 Municipal Development Plan Bylaw No. 1008/DEV/2024" and attached hereto as Schedule A is hereby adopted.
- 3. That Bylaw No. 868 and any amendments thereto are hereby repealed.

C. SEVERABILITY

4. If any portion of this Bylaw is declared invalid by a court of competent jurisdiction, then the invalid portion shall be severed.

D. ENACTMENT

This Bylaw shall come into effect after receiving third reading and upon being signed.

William Pete Dechant attended the Public Hearing and spoke of his general support for the draft Municipal Development Plan. However, he expressed concern regarding provisions to review the Municipal Development Plan regularly. Further, he advocated that there is a strong need for public engagement for development within the Municipality particularly with regards to large-scale projects including, but not limited to: mining, nuclear, hydroelectricity and so forth. Further, he noted that on page 87, the MDP states that the M.D. of Fairview No. 136 may express support for large and small alternative energy develops, but without definitions (Submission Time: 9:40 a.m. to 10:05 a.m.

Bev Rolling attended the Public Hearing, but did not make a formal submission.
